Dear Neighbors,

As we begin our second year in the Constable Patrol Program, I want to thank each and every one of you for making the additional investment in our neighborhood to make it safer for everyone. While one crime is too many if it happens to you, crime is down in our area. HPD considers us a low-crime area and therefore assigns little resources for the prevention of crime and is more of a reactive force in our area. Combine that with the reported 500 HPD officers retiring in the next year, and it is even more imperative that we take a more proactive role in securing our neighborhood.

VC Patrol's goals this year are to improve communication with members by enhancing our website and publishing a monthly email newsletter. The newsletter will update you on happenings in the neighborhood, criminal activities and other information pertinent to our area. We are also evaluating the possibility of adding an additional patrol contract beginning in August. That would give us two dedicated deputies patrolling our neighborhood only. To accomplish this task without increasing membership fees, we need everyone to renew their membership.

Lastly, VC Patrol is maintained by a few very dedicated volunteers. To meet our goals and to become more active in taking on other community issues, we need more of you to volunteer. Join our Community Emergency Response Team
